

School Savings Program Sweepstakes

Official Rules

- 1. The School Savings Program Sweepstakes (Promotion) consists of separate month-long sweepstakes (Sweepstakes Period). The Promotion is conducted in the United States and begins at 12:01 am Eastern Daylight Time (EDT) on August 15, 2025, and ends at 11:59 pm Eastern Standard Time (EST) on May 15, 2026 ("Promotion Period"). The Promotion Period will be divided into separate sweepstakes periods (Sweepstakes Period). Each Sweepstakes Period will begin at 12:01 am on the fifteenth day (15th) of the month and end at 11:59 pm on the fourteenth day (14th) of the following month. Sponsor's computer is the official time-keeping device for the promotion.
- 2. Use promo code "SCHOOL" when opening an account online or in-branch and make at least one deposit per month for three consecutive months during the Sweepstakes Period to receive one automatic entry. BayPort will add the promo code "SCHOOL" to existing member accounts linked to a school partner.
- 3. To participate in the sweepstakes and be eligible to win a prize you must be a legal U.S. resident and 18 years or older at the time of entry.
- 4. BayPort Credit Union employees and Board members, as well as their immediate family members, are not eligible.
- 5. One (1) member will be chosen within 15 business days following each Sweepstakes Period. Each member chosen will receive \$1,000 deposited to their BayPort Savings Account. In addition, the winner will identify the school they are associated with to receive an additional \$1,000 for the school or the school's PTA.
- 6. Payments will be directly deposited into the member's BayPort Savings Account, in the amount up to \$1,000.00. No cash awards will be given.
- 7. The winner will be contacted by BayPort Credit Union within 15 business days of each Sweepstakes Period.

Promotion Time and Organizer

School Savings Program Sweepstakes (Promotion) is conducted in the United States and begins at 12:01 am Eastern Daylight Time (EDT) on begins at 12:01 am Eastern Daylight Time (EDT) on August 15, 2025, and ends at 11:59 pm Eastern Standard Time (EST) on May 15, 2026 (Promotion Period). The Promotion is organized by Newport News Shipbuilding Employees Credit Union d/b/a BayPort Credit Union, One BayPort Way, Suite 350, Newport News, VA 23606 (in this document named as BayPort Credit Union or Sponsor).

Sweepstakes conduct rules have been set by BayPort Credit Union and all decisions to conduct this sweepstakes are final and mandatory to all participants in this Sweepstakes.

Participating in the Promotion and Promotion Prize

BayPort Credit Union will run the Promotion from 12:01 am Eastern Daylight Time ("EDT") on begins at 12:01 am Eastern Daylight Time ("EDT") on August 15, 2025, and ends at 11:59 pm Eastern Standard Time ("EST") on May 15, 2026 (Promotion Period).

In order to participate in the sweepstakes, members use promo code "SCHOOL" when opening an account online or in-branch and make at least one deposit per month for three consecutive months during the Sweepstakes Period to receive one automatic entry. BayPort will add the promo code "SCHOOL" to existing



member accounts linked to a school partner.

Each Sweepstakes Period will begin at 12:01 am on the fifteenth day (15th) of the month and end at 11:59 pm on the fourteenth day (14th) of the following month.

One (1) member will be chosen within 15 business days following each Sweepstakes Period.

The winner has ten (10) business days following contact to accept the prize, or the prize may be forfeited, or another winner may be chosen.

BayPort Credit Union will award one winner \$1,000 each Sweepstakes Period deposited directly into their Savings Account. In addition, the winner will identify the school they are associated with to receive an additional \$1,000 for the school or the school's PTA. All federal, state and local taxes associated with the receipt or use of the prize are solely the responsibility of the winner. The winner(s) will receive a 1099 IRS form from BayPort Credit Union for the cost of the promotion prize won. If the prize is valued at less than \$600.00, BayPort Credit Union will not provide a 1099 IRS form. Upon accepting the award, the winner will be asked to sign a photo release form, authorizing BayPort Credit Union to use their name and/or likeness in announcing the results, and for related advertising and promotional purposes, without additional compensation.

If the winner is unable to collect the prize, then he/she cannot demand to have it replaced with an alternative prize/item/service.

Odds of winning depend upon the number of total eligible entries received.

BayPort Credit Union has the right to end the Sweepstakes if there should be an unforeseen obstacle or force that inhibits the possibility to continue with the Sweepstakes. Once this has happened, a notice will also be placed on the BayPort Credit Union website. Sponsor is not responsible for errors and Sponsor may rescind, cancel or revoke this sweepstakes based on any factor outside of its reasonable control without liability at its sole discretion. Entry forms become the sole property of Sponsor and will not be returned.
